

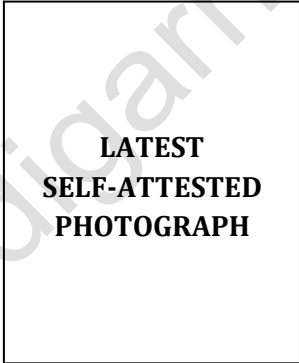

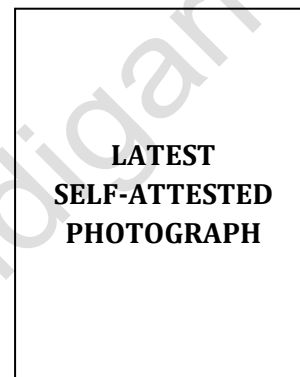

TERMS AND CONDITIONS FOR "HEALTH & SKIN CARE SERVICES"

1. **This contract is only reserved for Female Applicants.**
2. That the above contract is from the **Date of Award to 31st May, 2025.**
3. (a) That the contractor will deposit a rent @ Rs. 2,862/- per month.
(b) The contractor shall install his/ her own electronic sub meter. Electricity charges will be paid **as per sub-meter reading @ Rs. 7/- per unit** by the contractor. In case sub-meter is not working, the contractor will be charged on average of three-months till faulty meter is replaced/ repaired.
(c) Fixed Water Charges of Rs. 210/- per month will be paid by the contractor.
4. That the contractor has to deposit Rs. 10,000/- in form of F.D. in the name of Principal, Post-Graduate Govt. College for Girls, Sector-42, Chandigarh as security within 10 days of the award of contract. The said security deposit shall be forfeited in favour of the college, in case of violation of any terms and conditions of the contract.
5. That the contractor shall deposit 6 months advance rent (*i.e.*, Rs. 2,862 x 6 = Rs. 17,172/-) once the contract is awarded. The rent of remaining period will be paid in single installment in the month of January, 2025 and the photocopy of the receipts of rent, water charges and electricity charges must be submitted to the accountant/ caretaker.
6. The seller should quote the rates of services in Financial Bid' Form-B'.

7. That the contractor shall display the **"RATE-LIST"** of all Services outside the Shop/ Sale

counter for the information of hostel residents.

8. The contractor shall keep her equipment's and the working place neat and clean.
9. Proof of her technical qualification in the relevant field (Certificate/ Diploma Course) should be attached along with the Technical-Bid.
10. (a) The contractor should charge as per the rates finalized during the award of contract. In case of any complaint, the contractor shall be liable to penal action as recommended by the contract committee which may lead to cancellation of contract and forfeiture of the entire amount of security.
(b) That the a contract can be terminated at any time if some gross violation of terms and conditions, misbehavior, misconduct, and use of sub-standard Products is reported. In such a condition the security deposit is also liable to be forfeited.
11. That the contractor shall employ **Female Staff only** after the verification of their antecedents by local police and inform the complete details of the staff to the Principal.
12. Initially the contract will be awarded for one Academic Session (2024-25). But if the work of the contractor is found to be satisfactory, then this contract may be extended for a period of another Two Academic Sessions (one session at a time) subject to the approval of Contract Committee. The rent will be increased @10% each year in case of renewal of this contract. The rates will also be revised as per inflation price index only after the proper approval of the Contract Committee.
13. That the contractor has to vacate the premises on **31st May, 2025** (if not extended or renewed) under all circumstances and all types of dues, charges, rent must be cleared otherwise the contractor will be declared as defaulter by the college authorities for future.
14. That the contractor/ applicant agrees to the said terms and conditions, then a signed copy of "**Terms and Conditions**" by the applicant/ contractor must be submitted along with Technical-Bid "**Form-A**".
15. The contractor must execute an agreement with the college regarding the said contract.
16. That if the applicant submits wrong/ false/ forged documents then he will be responsible on his own. His contract will be terminated immediately and his security will be forfeited and he will be blacklisted for future.
17. Applications received after due date and time will not be considered. Any legal matter will be dealt within the jurisdiction of U.T., Chandigarh.
18. If rates quoted by the applicants are found to be same, then preference will be given to the person having maximum experience.
19. That the decision of the contract committee will be final and hence binding on the contractor under all circumstances.
20. The contractor will keep her shop open from 9:00 A.M. to 5:00 P.M. on all working days.
