#### TERMS AND CONDITIONS FOR "CHAAT-PAPRI SHOP"

- 1. That the above contract is from the **Date of Award** to **31**st **May, 2025**.
- 2. (a) That the contractor will deposit a rent @ Rs. 2,463/- per month.
  - (b) The contractor shall install his/ her own electronic sub meter. Electricity charges will be paid as **per sub-meter reading @ Rs. 7/- per unit** by the contractor. In case sub-meter is not working, the contractor will be charged on average of three-months till faulty meter is replaced/repaired.
  - (c) Fixed Water Charges of Rs. 210/- per month will be paid by the contractor.
- 3. That the contractor has to deposit Rs. 10,000/- in form of F.D. in the name of Principal, Post-Graduate Govt. College for Girls, Sector-42, Chandigarh as security within 10 days of the award of contract. The said security deposit shall be forfeited in case of violation of any terms and conditions of the contract.
- 4. That the contactor shall deposit 6 months advance rent (*i.e.*, Rs. 2,463 x 6 = Rs. 14,778/-) once the contract is awarded. The rent of remaining period will be paid in one installment in the month of January, 2025 and the photocopy of the receipts of rent, water charges and electricity charges must be submitted to the accountant/ caretaker.

- 6. That the contractor shall display the "Rate-List" outside the Shop/ Sale counter for the information of college staff and students.
- 7. The contractor shall always keep their working area neat and clean.
- 8. He should always use only **Clean-Filtered water** for all his preparations.
- 9. He should not use any Palm-Oil (as refined oil) and Margarine (as substitute of butter) for any type of cooking purpose.
- 10. Use of Newspaper Sheets for wrapping of food items sold at the sale counter is strictly prohibited under all circumstances. Use of only good quality tissue papers is allowed.

- 11. The contractor must also have a copy of "Food License". In case of its non-availability at the time of applying for this contract, they must get it within One-Month in case of the award of this contract.
- 12. He should be wearing **Head-Cap** and **Gloves** while preparation of food and during its service. Proper hygiene of all the workers should be maintained.
- 13. (a) The contractor should charge as per the rates finalized during the award of contract. In case of any complaint, the contractor shall be liable to penal action as recommended by the contract committee which may lead to cancellation of contract and forfeiture of the entire amount of security.
  - (b) That the a contract can be terminated at any time if some gross violation of terms and conditions, misbehavior, misconduct, and use of sub-standard Products is reported. In such condition the security deposit is also liable to be forfeited.
- 14. That the contractor shall employ staff only after due verification of their antecedents by local police and inform the complete details of that staff to the Principal.
- 15. Initially the contract will be awarded for one Academic Session (2024-25). But if the work of the contractor is found to be satisfactory, then this contract may be extended for a period of another Two Academic Sessions (one session at a time) with the mutual consent of Contractor and the Contract Committee. The rent will be increased @10% each year in case of renewal of this contract. The rates will also be revised as per inflation price index only after the proper approval of the Contract Committee.
- 16. That the contractor has to vacate the premises on 31st May, 2025 under all circumstances and all types of dues, charges, rent must be cleared otherwise the contractor will be declared as defaulter by the college authorities in future.
- 17. That the contractor/applicant agrees to the said terms and conditions, then signed copy of "Terms and Conditions" by the applicant/contractor must be submitted along with Technical Bid "Form-A".
- 18. The contractor must execute an agreement with the college regarding the said contract.
- 19. That if the applicant submits wrong/ false/ forged documents then he will be responsible on his own. His contract will be terminated immediately and his security will be forfeited and he will be blacklisted for future.
- 20. Applications received after due date and time will not be considered. Any legal matter will be dealt within the jurisdiction of U.T., Chandigarh.
- 21. If rates quoted by the applicants are found to be same, then preference will be given to the person having maximum experience.
