5. ‘**Technical-Bid**’ Proforma for technical evaluation of the bidder is at **Annexure-E**.
6. ‘**Financial-Bid**’ Proforma is at **Annexure-F**.
7. ‘**Affidavit**’ regarding Non-Black Listing/ Non-Prosecution is at **Annexure-G**.
8. ‘**Declaration of Solvency**’ is at **Annexure-H**.

Any cutting, overwriting, etc. on any document page should also be initialed (duly signed). *In case of violation of above-mentioned condition, the submitted Bid shall stand rejected.*
12. **Bidder** must have either of their **Residential Address/ Head-Office/ Branch-Office** in the **Tri-city (Chandigarh/ Panchkula/ Mohali)** area only. The **Rent-deed** will not be accepted as a proof of their Residential Address. In case the bidder does not own a residence as prescribed in the Tri-city, he must have had his head-office/ Branch-office in the Tri-city (Chandigarh, Panchkula or Mohali) continuously for a period of not less than 3 years for which sufficient proof shall be submitted
13. The Bidder should submit their Bid in two-parts through GeM only, *i.e.*:

  - “**Financial-Bid**” is to be submitted online only at <https://www.gem.gov.in/>
14. Rates approved for Mess charges shall be applicable as per the weekly **MENU** given at ‘**Annexure-F**’.
15. The last date for submission of online Bid is **as per the GeM-Tender schedule**.
16. The Bids shall be opened in the Office of Principal, P.G.G.C.G.-42, Chandigarh as per GeM schedule. In the event of the last date of opening of bids being Sunday or being declared as a holiday, then this process shall be completed on next working day at the same time and venue.
17. Only those Bidders/ Applicants will be considered and shortlisted for further Financial Evaluation who have a minimum **Three-Year** experience in the last 5-Years (from the date of publishing this

Tender), of serving the North-Indian Cuisines (in Breakfast, Lunch and Dinner) in only Girls College of Tri-city (Chandigarh, Panchkula or Mohali) and to at least 300 students, since most of the Hostel Residents of P.G.G.C.G.-42, Chandigarh will come from the state of Punjab, Haryana and Himachal Pradesh.

18. Relevant work **Experience Certificates of three-years** of running Hostel-mess in only Girls College of Tri-city (Chandigarh, Panchkula or Mohali) and indicating the total number of students catered to during that contract period, required to be uploaded online on GeM Portal along with the submitted Bid.
19. The Bidder's whose Bids are Technically qualified and accepted for Financial-Bid evaluation will be informed through proper channel. **They are required to supply a Food-Sample (for one person)** indicated as Lunch to be served during this contract. **The Contract Committee will inspect the quality, taste, quantity, etc. of submitted Food-sample for further shortlisting.**
20. **The Financial/ Price-Bid of only those bidder's will be opened afterwards whose food-samples are found satisfactory and have been shortlisted** after its acceptance by the College Contract Committee.
21. Transfer of Contract or sub-letting of Hostel-Mess Premise to any 3<sup>rd</sup> party will not be allowed under any circumstances.
22. The Bidder must furnish the valid Income Tax/ PAN/ GST Number. A copy of latest GST Challan of related food or Mess services in the Tri-city should be uploaded along with the submitted Bid.
23. **The Contract shall be Awarded initially for a period from 15<sup>th</sup> July, 2025 till 31<sup>st</sup> May, 2026 which may be further extendable on Yearly basis upto a maximum period of next Two-Years on the existing terms and conditions (T&C) and may also be subjected to the satisfactory work performance of the Contractor in its previous term.**
24. **The Contract committee reserves the right to revise the Rates of Contract (upto 10% of Financial/ Price-Bid), as per the Inflation-index of RBI while extending the contract. The Performance Security (ePBG) amount will also be increased accordingly.**
25. **No Junk-Food item(s) are to be served in the Hostel Mess. *Palmolein (Palm) Oil and Cotton-seed Oil shall not be used for any type of cooking purpose at all.***
26. Since the college follows the policy of 'Plastic-Free Zone'. Hence, **Bio-Degradable materials should preferably be used**, wherever required.
27. **Maintenance of proper hygienic conditions, while preparing and serving the food under all circumstances, is the mandatory and non-negotiable condition for executing this contract.**
28. The Mess Contractor may arrange for the required Cooking and Serving utensils including Deep-Freezer, Refrigerator, Exhaust-fans, Burners & LPG-cylinders, etc. on their own. If the college provides any of these items to the contractor, the same has to be returned in the working condition only, while surrendering this contract. In case of misuse of given items, the contractor is liable to

pay the servicing cost of the defective item while its handover to college Caretaker at the end of this contract.

29. The successful bidder shall deposit **EMD (2% of total contract estimated Bid-value)** and Performance Bank Guarantee (**ePBG**) amounting to **5% of the Contract-Value** (having an extended validity of 60 days beyond the date of termination of this Contract), in the form of Fixed-Deposit Receipts/ Bank Guarantee from any Commercial Bank (within Chandigarh) in an acceptable form within **15-days** from the **“Date of Award of Contract”** by the College, **failing which appropriate penal action will be taken against the bidder.**
30. A **Service Agreement** shall be made/ executed at Chandigarh by the contractor with the college authority as per **‘Annexure-B’**. In the event of any dispute related to the interpretation of rights or liabilities arising out of this agreement, the same shall, at first instance, be amicably settled between the parties. In case, the dispute is not settled amicably, then the matter shall be referred to the Contract Committee and finally to the College Principal whose decision shall be final and binding upon both the parties.
31. The applicable law governing the Service Agreement shall be the law of India. The courts of Chandigarh alone shall have the jurisdiction to try any matter, dispute or reference between the parties arising out of this agreement. It is specifically agreed that no court outside and other than Chandigarh Administration shall have jurisdiction in the matter.
32. The Principal of P.G.G.C.G.-42, Chandigarh reserves all the rights to accept or reject any Bid without assigning any reason and also to impose/ relax any terms and conditions of the tender keeping in view the interest of the institution and their students.
33. **The Contractor or his workers shall not use or sell any tobacco products, alcoholic product and drugs of any type, prohibited items, as laid down in the Law.**
34. Seller must attach a copy of **Food License** obtained from the State Food Licensing Authority and Food Safety and Compliance System (**FSSAI License**) obtained from the website, <https://foscoss.fssai.gov.in/>.
35. In case of repeated violations of any terms & conditions (T&C) as stated above or mentioned in the Service Agreement, the awarded Contract will be terminated and the security will be forfeited.

College for Girls, Sector- 42, Chandigarh, invites Bid from reputed Contractors having minimum **Three-Year** experience in the last 5-Years (from the date of publishing this Tender), of serving the North-Indian cuisine (Breakfast, Lunch and Dinner) in only Girls College of Tri-city (Chandigarh, Panchkula or Mohali) and to at least 300 students, since most of the hostel residents of P.G.G.C.G.-42, Chandigarh will come from the state of Punjab, Haryana and Himachal. Relevant work **Experience Certificates of three-years** of running Hostel-mess in only Girls College of Tri-city (Chandigarh, Panchkula or Mohali) and indicating the total number of students catered to during that contract period, needs to be uploaded online along with the submitted Bid.
2. Interested Bidders must submit their Bid online through GeM-Portal of Govt. of India <https://www.gem.gov.in/>. However, for general information, guidance and reference, the Tender-Document can also be viewed & downloaded from the P.G.G.C.G.-42, Chandigarh college website <https://www.gcg42.ac.in/> .
3. Bids which are not as per the prescribed format or any deviation from the terms and conditions (T&C) of the Tender Notice shall not be entertained and are liable to be rejected.

5. The Bids shall be opened in the Office of Principal, P.G.G.C.G.-42, Chandigarh as per GeM schedule. In the event of the last date of opening of bids being Sunday or being declared as a holiday, then this process shall be completed on next working day at the same time and venue.

**SERVICE AGREEMENT FOR “NEW HOSTEL MESS”**

Agreement between the Principal, Post-Graduate Government College for Girls, Sector- 42, Chandigarh and \_\_\_\_\_ w.e.f. 15<sup>th</sup> July, 2025 till 31<sup>st</sup> May, 2026 on the following terms & conditions: -

- a) The successful bidder shall deposit **EMD** (shall be of the value of **2%** of contract value, where it is applicable) and Performance Bank Guarantee (ePBG) amounting to **5% of Contract Value** (with a validity of 60 days beyond the date of termination of contract), in the form of Fixed Deposit Receipts/ Bank Guarantee from any Commercial bank (within Chandigarh) in an acceptable form within **15-days** from the “**Date of Award of Contract**” by the College.
- b) After acceptance of Contract offer or after signing of agreement if the Firm/ Individual fail to start the Hostel Mess within 10 days, the contracts can be cancelled and the Earnest money/ Security money shall be forfeited.
- c) That the Contractor will be required to submit the Mess-Bill (inclusive of GST) in the Hostel Office in duplicate by the 3<sup>rd</sup> of every month duly verified by the concerned Hostel Warden/ Superintendent
- d) That Contractor will be paid net amount of the Mess-Bill (after deduction of **6.25%** as per **Annexure-D**) on monthly basis by 10<sup>th</sup> of every month (subject to revision as per Central Govt. rules).
- e) Menu and Schedule of the Meals to be given to the Hostel Resident Students is as per Annexure-C.
- f) **ADDITIONAL TERMS & CONDITIONS (ATCs):**
  1. **Only fresh and seasonal vegetables are to be used for daily food preparations.**
  2. **No payment will be made** during Panjab University notified Winter-Break and Summer-Break.
  3. During December and May Final Semester Examinations, in case the Student Vacates the Hostel before 15<sup>th</sup> of the respective month, she will pay mess charges for 15 days only. But if the student leaves the hostel after 15<sup>th</sup> of concerned month, then she will pay for additional number of days she stays in the hostel before the start of Panjab University notified Winter and Summer vacations.
  4. That the Income-Tax (TDS) and GST as per applicable rules for F.Y. 2025-26 shall be deducted.
  5. Any Member of the “**Hostel Welfare**” Committee can check the quality of meals, tea, etc. If any particular meal is not properly cooked or found unfit for consumption by the committee, the Contractor has to arrange any other/ substitute food for the same.
  6. The Contractor will be responsible for the proper maintenance of the furniture, electrical and electronic gadgets handed over to him by the college Caretaker. The Contractor shall hand over all the articles issued to him at the completion of period of Contract to the college Caretaker in

perfect working condition (except normal wear and tear), failing which the institute will be at liberty to recover the cost of all such damages caused to the equipment(s) from the contractor's refundable security deposit.

7. The Contractor is required to keep Wheat Flour, Dals, Sugar, Bread, etc. in the covered containers. He is to ensure that only branded Milk, Rice, Atta, Cooking Oils, Spices and Tea leaves of good quality are used.
8. ***Palmolein (Palm) Oil and Cotton-seed Oil shall not be used for any type of cooking purpose at all.***
9. Lunch and Dinner should consist of seasonal vegetables in the menu.
10. No outsiders/ unknown persons will be allowed to enter the Hostel-mess from the Kitchen area or *Dine-in* area without the prior permission or knowledge of Hostel Warden or Superintendent.
11. The College can deduct any excess payment made to the Contractor from the subsequent Mess-Bill/ Performance Bank Guarantee/ Security Deposit.
12. The Contractor must appoint sufficient number of Staff to cook & serve the food. Presence of **One Female Staff** is mandatory at the time of serving the food.
13. A **Complaint-Book** (for getting the feedback of Hostel-Residents) should be maintained and submitted to the Hostel Warden Office for its scrutiny, on daily basis.
14. **CLEANLINESS**: It shall be the responsibility of the Contractor to employ adequate number of cleaners and sweepers and provide them with adequate and necessary equipment's/ materials for keeping the kitchen and dining area properly cleaned. **Anti-Rodents** and **Pest-Control measures** will also be strictly followed and it will be the responsibility of the Contractor to ensure that the premise is free from these noxious animals. No special college support staff will be provided for this purpose.
15. Since the College follows the policy of '**Plastic-Free Zone**'. Hence, **Bio-Degradable materials should preferably be used**, wherever required.
16. All Hostel-Mess Staff must wear proper uniform (head-cap, gloves, kitchen-apron, etc.) and also must have their **Identity-Card** provided by the contractor, while on duty. In any case the Mess Staff should not be below the age of 18 years. A detailed list of all the employed staff and their full credentials must be submitted to the Principal's office by the Contractor.
17. The Contractor is also required to get the medical-checkup done (from any Govt. Hospital/ Govt. Dispensary in the Tri-city) of all of his workers and submit their fitness certificates to the office of Hostel Warden/ Superintendent.
18. The Mess Contractor will get the antecedents of his employees duly verified from the concerned police station *i.e.*, Police Station, Sector-36, Chandigarh and give list of employees to the college authorities. Any servant replaced, will be immediately informed to the Hostel authorities.
19. The Contractor must have a copy of **Food License** obtained from the State Food Licensing

Authority and Food Safety and Compliance System (**FSSAI License**) obtained from the website, <https://foscoss.fssai.gov.in/>. Besides that, he will be held responsible for any negligence (if found any) in preparing and serving the day-to-day meals.

20. All the Hostel Mess Staff must wear proper and clean uniform (should be light-grey or sky-blue shirt with black trousers and white-canvas shoes) provided by the contractor, while on duty. No Mess Staff should be hired below the age of 18 years (**no Child Labour allowed**).
21. Smoking, drinking, intake of drugs by the Contractor or any of his workers is strictly prohibited in Hostel Mess or College campus.
22. The Contractor shall use the allotted premise area for the cooking and serving purpose only. The Mess staff should stay in the designated servant's room otherwise.
23. After completion of this contract, it shall be the duty of contractor to remove all the persons deployed by him and ensure that no person creates any disruption/ hindrance/ problem of any nature.
24. The Contractor is required to submit Labour License (if applicable), within 30 days from the Start of this Contract and obey all the Labour Laws of Govt. of India and U.T. Administration, Chandigarh.
25. Liability/ responsibility in case of any fire related accidents or any other accidental injuries/ death to mess workers/ in-maids or any of his staff shall be that of the Contractor. The College authorities are not responsible or liable to pay any compensation/ dues/ charges in such cases.
26. **The Contract shall be Awarded initially for a period from the 15<sup>th</sup> July, 2025 till 31<sup>st</sup> May, 2026 which may be further extendable on Yearly basis upto a maximum period of next Two-Years on the existing terms and conditions (T&C) which is also subjected to the satisfactory work performance of the Contractor in its previous term.**
27. **The awarded contract will be for serving meals to 300 hostel residents with 25% increase or decrease of Students during each academic session.**
28. **The contract committee reserves the right to revise the Rates of Contract (upto 10% of Financial/ Price-Bid), as per the Inflation-index of RBI while extending the contract. The Performance Bank Guarantee (ePBG) amount will also be increased accordingly.**

**TERMS OF PAYMENT**

1. Contractor will be required to submit the Mess-Bill in duplicate, duly verified by the Hostel Warden, College Bursar & Superintendent, by the 3<sup>rd</sup> of every month in the College office (to the Mess clerk).
2. Payment of all the bills submitted by the Contractor will be made by the **10<sup>th</sup> of Every Month** after realization/ collection of the same from the hostel students.
