This memorandum of Understanding (MOU) is entered between Pidilite Industries Limited represented by its undersigned on the one part; and **FINE ARTS DEPARTMENT POST GRADUATION GOVT. COLLEGE FOR GIRLS** represented of the other part; Whereas Pidilite Industries Limited and **POST GRADUATION GOVT. COLLEGE FOR GIRLS** shall be hereafter jointly referred to as the "Parties" and singularly as a "Party".

The Parties have decided to agree to establish industry-academic collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (MOU), Pidilite Industries Limited and **POST GRADUATION GOVT. COLLEGE FOR GIRLS** agree on following activities:

1. Pidilite Industries Limited will provide support for skill-oriented courses to be started at **FINE ARTS DEPARTMENT POST GRADUATION GOVT. COLLEGE FOR GIRLS**. To achieve this senior official Artist from Pidilite Industries Limited will work in close collaboration with faculty members of **FINE ARTS DEPARTMENT** Senior officials Artist from Pidilite Industries Limited will share their knowledge and experience by way of taking practical instruction sessions workshops, participating in seminars and other academic activities of **FINE ARTS DEPARTMENT POST GRADUATION GOVT. COLLEGE FOR GIRLS**
2. Pidilite Industries Limited will arrange to provide atleast two periodic workshops in a session to the students of **POST GRADUATION GOVT. COLLEGE FOR GIRLS** to enable them to get practical exposure and learning from interaction with trainers from Pidilite Industries Limited.

3. **Pidilite Industries Limited** will be given priority status like invitation for zero-day placements etc.

Each party shall appoint one nodal officer to periodically review and identify ways to strengthen cooperation between them.

This MOU will take effect from the date it is signed by representatives of the parties. It will remain valid for three years, and may be continued thereafter, after suitable review and agreement. Either Party may terminate the MOU by giving written notice to the other Party three months in advance. Once terminated neither **Pidilite Industries Limited** nor **POST GRADUATION GOVT. COLLEGE FOR GIRLS CHANDIGARH** will be responsible for any losses, financial or otherwise, which the other Party may suffer. However, **Pidilite Industries Limited** and **POST GRADUATION GOVT. COLLEGE FOR GIRLS** will ensure that all activities in progress are allowed to be completed successfully.
